- 7. **Modelling Climate Risks:** Developing models and methodologies to assess and manage financial risks associated with climate change, including physical, transition, and liability risks.
- 8. **Policy Issues of Climate Finance:** Examining policy challenges and opportunities in the design and implementation of climate finance policies at the national and international levels.
